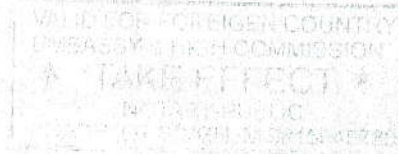

In the above cited subject:

2. On the basis of documents and affidavits provided by the Management of the School and keeping in view the recommendations of Distt. Education Officer (S.E.) Ludhiana and Director Education Department (S.E.) Punjab, Chandigarh, the No Objection Certificate has been issued by Punjab Government on the following conditions:

1. In case, at any future time, it is found after any complaint/inspection that the application for getting the no objection certificate was made to the government on the basis of wrong information or that the instructions given by the government from time to time have not been followed, and if the conditions given in the affidavit have not been obeyed, then the no objection certificate will be cancelled.

2. In your school, Punjabi subject will be compulsory till tenth standard. C.B.S.E./I.C.S.E. New Delhi will manage for the examination of Punjabi subject in these schools. It is also mentioned that in case of not doing so, the no objection certificate will be cancelled.

3. School management will follow the notifications given under R.T.E. Act 2009 and rules of R.T.E. Act 2009 made for Punjab Government.

4. After getting the affiliation from C.B.S.E. New Delhi, the school management will be responsible to pay the salary and other allowances to the teaching and non-teaching staff of school through account payee cheques as given to the government employees. In case of not doing so, the no objection certificate will be cancelled.

5. You and your management will ensure that you will provide necessary information and co-operation as and when required by the District Education Officer of your district or any other senior authority.

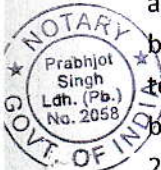
